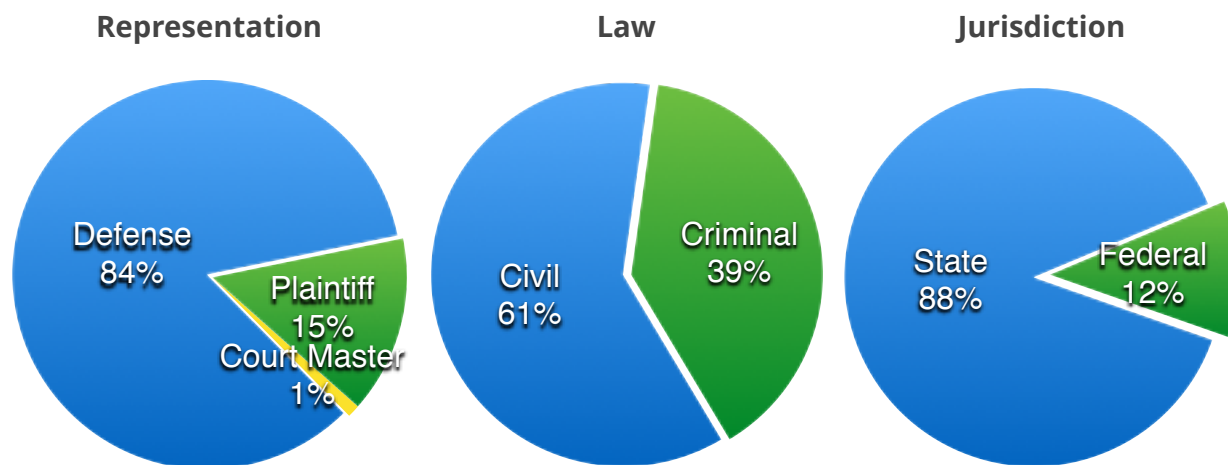


David W. Rismann
